Dear Lowline Breeders,

The 2016 National Lowline Sale will be held on Thursday, January 21, 2016 at 1:00 PM at the National Western Stock Show in Denver, Colorado. It is held, of course, as part of the action packed 3 days including the National Lowline Show, Annual Meeting and Banquet and is sponsored by the American Lowline Registry. Entries are now being accepted for the sale. If you are interested in consigning, please look over the enclosed information and return your entries to Auction Effertz, Ltd. **by November 15.**

1. All sale cattle must be entered in the National Western Lowline Show. The deadline for show entries is November 20, 2015. National Western show entry forms are available at www.nationalwestern.com. If you have trouble finding an entry form, call Jan at 701-223-5202.
2. You must comply with National Western Stock Show health and brand regulations. They are also available at www.nationalwestern.com.
3. All females entered in the National Sale must be officially calfhood vaccinated for brucellosis.
4. All breeding age bulls entered in the National Sale must be fertility tested and a copy of the fertility test must accompany the bull to the sale.
5. All sale entries must have the original ALR registration paper available prior to the sale or the animal will not be allowed to sell and entry fees will be forfeited. This does include any calves selling at the side of their dams.
6. All percentage cattle consigned to the National Sale must be DNA parent verified to at least one Lowline parent. This test must be completed prior to the sale and results sent to Auction Effertz, Ltd.
7. The entry fee for the National Sale is \$100 per lot. This entry fee will apply to your sale expense if the animal goes through the sale ring. It will be forfeited if an animal is withdrawn from the sale after it is cataloged. Entry forms for the National Lowline Sale can be found at www.auctioneffertz.com. 8. Sale expense for the National Sale will be prorated on a percentage basis. The sale is sponsored by the American Lowline Registry and 1% of the sale proceeds will be earmarked for the ALR.
