Dear Aberdeen Breeder,

We have had several breeders contact us in the past couple of weeks who are interested in marketing some cattle before the first of the year. Combined, the cattle are a great sale offering, featuring fullbloods and Moderators, a few top show females, some cow/calf pairs and bred females and a few top quality breeding age bulls. With this in mind, we are accepting entries for the Rock Solid Aberdeen Foundation Sale, Saturday, December 8 at 1:00 PM at "The Rock", formerly Rock Island Livestock Auction, Rock Island, Illinois.

We will need to gather entry materials quickly for the sale in order to have the catalog printed and mailed about a month before the sale. The entry deadline is October 16. Remember, we will use only high quality photos. If you need assistance finding a photographer to assist you, please let us know and we will try to help you find someone in your area.

1. All sale cattle, including calves at the sides of cows, must be registered with the American Aberdeen Association.
2. Sale cattle do not need to be halter broke but they must be quiet and well presented.
3. Sale cattle must be accompanied by interstate health certificates and brand inspection as required by Illinois health regulations. Animals should be identified on the health certificate with both tattoo and metal tag number or EID. Bangs vaccinated females should have their OCV tattoo on their health papers.
4. There will be a \$100 per lot sale entry fee that must accompany the entry forms. This entry fee will be applied to sale expense. Sale expense will be prorated on a percentage of sale gross basis. Fees for sale management, auctioneer, webcast, advertising, facilities and catalog will be distributed equally among the consignors based on their percentage of the sale gross. Other expenses such as fitting and transfer fees will be in addition to this prorated sale expense. If an animal is withdrawn from the sale after it is cataloged, the entry fee will be forfeited.
5. We recommend, but do not require, that females in the sale be calfhood vaccinated for Brucellosis. Bulls 15 months or older should be fertility tested and Trich tested. Bred females should be preg checked. This information should be on your health paper.
6. All sale cattle must have a legible tattoo that matches their registration paper and health paper. There will be a \$10.00 per head charge if the sale staff has to tattoo an animal.
7. Fitting services will be available at an extra charge. Please have cattle in place on Thursday so we have time to get them fit and penned.
