Dear Aberdeen Breeder,

The format of the 2021 National Aberdeen Sale Supreme Sale has been changed to an online sale with SmartAuctions. Many of the sale cattle will be at the National Western which will be beneficial for transportation but they are not required to be in Denver. The sale will close at the Embassy Suites on Sunday, January 16 at 4:00 PM. People can place their final bids before the Annual Meeting. At the discretion of the sale manager, a few exceptional additions from the National Show may be accepted into the sale.

Please read through the rules and requirements for the sale:

- 1, Registration paper there will be a link to the AAA registration paper on the sale site on SmartAuctions so all sale animals must be registered prior to the sale.
- 2. A professional quality photo and video. Good cattle, well fitted and presented with good photos and videos sell best in an online auction. We will not be able to use poor photos or video.
- 3. We need your photos and videos by January 1. If you need to send video footage, contact Jan (701-471-0152 or effertz@bektel.com) and she will send you a link to a dropbox folder. Video files are too big to email. We can also take a youtube link if your videographer has posted them.
- 4. Sale cost will be \$100 non refundable entry fee plus 8% which does include 1% for the AAA.
- 5. Please be sure to check the tattoos for your sale cattle and be sure they are legible and accurate.
- 6. Please submit preg check for bred females and/or a fertility test for breeding age bulls with your sale entries. Bulls selling to certain states will require a trich test and that is the responsibility of the seller.
- 7. Consignors will be responsible for obtaining necessary health certificates for shipping their consignments after the sale. Cooperation is necessary in making trucking arrangements, meeting trucks, etc. Trucking expense is the responsibility of the buyer.
- 8. Embryos and semen that are in demand will be accepted for the sale. However, do the math. With a \$100 non refundable entry fee, the semen and embryos need to be very marketable to make it a worthwhile consignment.
